

## HLT52015 DIPLOMA OF REMEDIAL MASSAGE (CRICOS Code 096008J)

### Qualification Outcomes

Diploma of Remedial Massage covers the provision of remedial massage treatment to clients with specific needs such as injury management, rehabilitation, palliative care and aged care. Classes for this course are a mix of theory and practical subjects, and include practical work in a salon environment. Practitioners at this level may supervise other massage therapists. Completion of the Diploma of Remedial Massage also provides the graduate with a significant number of credits for subjects into a Bachelor of Health Science (Musculoskeletal Therapy). Upon successful completion of the Diploma, students will be able to join AAMT and register with Work Cover and Private Insurer(s) for their Provider Number.

### Study Options

This full time course runs for 52 weeks and includes a combination of face to face classroom instruction and practical experience.

Training and assessment are delivered by Demi International Beauty Academy (RTO #32542) under a Third-Party Partnership Agreement.

Demi International is an Approved ITEC Centre to deliver ITEC qualifications in Remedial Massage.
